Cylinders are not refilled; they are salvaged for scrap. The Arc of Butler County—a nonprofit organization that employs people with intellectual and developmental disabilities—salvages, recycles, and properly disposes of all metals. Before any cylinder is returned for recycling:

- 1. Remove valves from all cylinders.
- 2. Return all cylinders in the specially-marked shipping box.

To remove a cylinder valve, use valve removing tool (P/N 711229) for removing the red Model R Cylinder series valve.

Use valve removing tool (P/N 711228) for removing the Model RP and Econo-Cal Cylinder series valve. This tool removes valves from the:

- tan steel cylinder.
- aluminum 58-liter Model RP Cylinder.
- aluminum 34-liter Econo-Cal Cylinder.

Follow instructions supplied with each tool.

To return a cylinder:

All empty cylinders must be returned in the special shipping box (P/N 711227). This box is addressed with appropriate shipping information and location: MSA Recycling Center c/o the Arc of Butler County.
